Academic credentials:

I passed my school leaving certificate from Shree Janta High School obtaining 72% percentage in 2070 B.S. Talking about my strengths, I am a hardworking and dedicated student who loves to overcome new challenges of life with a smile. I was considered as a laborious, honest, disciplined and sincere student throughout my school life. After that, I joined +2 level in Classic College International in the science stream due to mental pressure from my family and relatives as most of the children of our relatives were studying either doctors or engineer. Later, I could not grow interested in the subject and realized that I am not a science person. However, I clung onto it, because of my love for biology, especially zoology where we get to study about animal ecology, biodiversity, and such. But, in other subjects like physics, chemistry and math I could not do well as it was too much vast for me and I failed in them. After a while I heard of the course that was completely suitable for me where the curriculum mostly focuses on related part that is animals. There were compulsory subjects similar to before like physics, math and chemistry however, I excelled in them and I was one of the top students in our college. I pursued my Diploma level course in Animal Science from Shree Janta Secondary School under CTEVT, Nepal. Because of my strong determination and hard work, I scored high percentage in Diploma in Animal Science, i.e., an aggregate of 78.83% percentages in the year 2019 in which I have been successful to secure second position. After that, I had an opportunity to work in a clinic as a veterinary technician at the place where I did my OJT (On Job Training) for three months where, I was provided with a boundless knowledge for my further studies for DVM (Doctorate in Veterinary Medicine). Due to my hard work, education, strong technical experience that I gained there, I was offered a decent income. Later on, I also had a chance to encounter experience of natural environments and wilderness with my mentors travelling to many places for natural resources and conservation which led me to this excitement degree of natural environment and wilderness. Given that I have studied in English Medium School, in my school and college life, English language has always been in the mightier side so I am very confident that English language is never going to be a problem during my study period and stay in Australia.

After completion of my IELTS I started doing research about various education providers in Australia and came to know about University of Tasmania. Having a fair background and keen interest in animals, I decided to apply for bachelor in natural environment and wilderness, as my intended course is reputed and renowned in UNIVERSITY OF TASMANIA. After that, I started to application process providing all the required documents.

Gap Clearance:

As I had completed my Intermediate of Science in Agriculture on the year 2018 and received my certificates on the year 2019, March. So after the completion of my higher education I had researched some of the institutes for the preparation of IELTS and made a decision to continue my IELTS classes and after the preparation, I had attempted examination on 23rd November and received my certificates on 6th December. So afterwards I started searching for some of the Universities in Australia but unfortunately from the month of February lockdown started due to pandemic. So due to it I was compelled to postpone my further study plan and also want to assure you that pandemic is only the reason for the gap on my studies.



Why Australia?

While exploring and researching different countries, I found out Australia as the best suited destination to study abroad. The universities of Australia provide wide range of courses for the international students. The teaching methodology is both the blend of theoretical as well as practical education.

There are limited opportunities in Nepal for higher degrees in the sector for animals. Also, the institutions in Nepal are far from being at par with the international standards. I aspire for an education, recognized all over the world and not just within the given geographical boundary. So, I decided to continue my studies in Australia. Australia is a multicultural, safe, friendly and welcoming society offering excellent environment for international students to adjust and study. Australian institutions are widely recognized for their excellence as they deliver practical and career-oriented education so that students can acquire required skills and knowledge to enhance their career. Australia provides dynamic and progressive education program with a reputation for excellence, globally recognized course and qualification.

Australia provides unique kind of education and a learning style that encourages innovative, creative and independent thinking culture.

More importantly, the nursing education in Australia is world renowned to be practical with primary focus on employment, which exactly fits my expectations. Graduates from Australia are very successful in finding jobs and holding prominent position in my country.

Australia also practices ESOS act (Education Service for Overseas Students) for international students which governs fundamental rights of international students and enables our rights to receive accurate information before enrollment, current courses fees, mode of study and other relevant information about institution.

CRICOS (Commonwealth Registration of Institutions and Course for Overseas Students) is also an important factor of Australian Education System which ensures quality education to international students.

TPS (Tuition Protection Service) and gun control system are other attractions of Australia.

The education system is carefully regulated by Australian government in order to maintain the high education standard. Learning in university of Australia would be a great experience.

Why not Nepal?



Nepal has very limited development in the sector of animals and insufficient education materials for students. I have completed my Diploma in Animal Science in Nepal and now I want to pursue higher education. For that, I have researched study options which are available in my home country Nepal but I decided to study in abroad. The quantity of universities is also very low. There are only 5 universities that are officially verified by the Nepal Government. As per my research, in Nepal, there are few universities but they are only providing specific courses only available at few universities like Tribhuwan University and Purbanchal University with a limited number of seats and there are no other partner institution and campuses for pursuing this course. Furthermore, the degree in Nepal has low demand and less market value in comparison with international degrees and international work experience.

After that the education system in Nepal is very weak. The teaching approach is more theoretical than a practical one. The board examination notice and results are never published on time. So, in order to make my future degree valued and wanted, it was necessary that I expand my research abroad. And my plan is to study Bachelor in natural environment and wilderness which provides many options as communication and thought, scientific research methods. And I am also more interested to experience a new education system from a developed country like Australia.

Why not other countries?

Studying abroad and getting an international degree has been a priority for so many students today. There is no doubt that there are various countries that I can apply for my postgraduate degree but there are various reasons for not choosing the countries like the USA, UK and Other European Countries.

USA: The requirement of GMAT and GRE courses along with high tuition costs is the main reason for not choosing the USA. The cost of living is also high in the USA. (\$1=NRS 118.07)

European Countries: The major reason for not applying to European countries is due to the language barrier. On the other hand, the weather is not favorable as there is an extremely cold climate. (1 EURO= NRS 143.38)

UK: The cost of living is high and low job security for international students. The constant amendment in policies regarding international students and in other various rules also makes it quite unstable to stay there. (1 POUND = NRS.158.77)

On the other hand, Australia is one of the best destinations for international students to gain highly qualitative education in prestigious and top-ranked universities which will benefit in future flexibility. Comparing the exchange rate of Australia and other countries, Australia has a lower exchange rate which makes the fee structure affordable for international students (1 AUD = NRs 86.05). Moreover, Australia's policies are highly favorable for international students which made me choose Australia over other countries.

As the Universities are a bit expensive than the University of Tasmania which is providing me the subject of my choice in a reasonable tuition costs and I also found University of Tasmania more preferable and suitable from every prospects. University of Tasmania provides a high graduate employment rate with advance technology and teaching, learning facilities. I am also attracted to the affordable tuition fees and suitable location.

Why Bachelor of Natural Environment and Wilderness?

I am applying to study Environmental Science and wilderness because of my enthusiasm for the environment and my fascination for living organisms. I have got all the information regarding job through online job portals like www.merjob.com, www.kumarijob.com, www.ramrojob.com. They are giving more priority to international degree holders than local degree holder. They are paying NPR 65000- 75000 per month to International degree holder but for the same job Nepalese Degree holder will just get a pay of NPR 25000 -40000 per month. It seems that my investment to get an Australian degree will be more beneficial for me to get a competitive job nationally and internationally as Australian degree is globally accepted.
